Thanks for the information. I'm familiar with the Sport Wales Fund you have alluded to, and I am aware that it is a very competitive process due to the open and varied nature of the applications they have for funding. I was under the impression that, due to the specific nature of the project (being a Tennis Court Refurbishment), then it might qualify for the Government, LTA/TW specific grant.

Should our contact with Sport Wales not be fruitful, would we be able to further discuss the fund with you when there is more clarity on the finances, or is it the case that the project we propose is too much of a stretch to meet the requirements of the LTA grant (i.e. if indeed it does require more than just resurfacing)?

We followed up with Sport Wales on potential for a project and they advised us to engage with the sporting body for such a project.
