Thank you kindly for your response. When was the request made to the County?

We can confirm that the Football Club are permitted to play training matches as of yesterday, with inter-club friendlies also scheduled in line with FAW guidelines. This is pending the lifting of the Club's internal suspension of all football activity, a decision taken by the Club in-line with the current lockdown situation and to be reviewed at the weekend.

The Rugby Club had also initially taken an internal decision to suspend all activity, since which time the WRU have enforced such sanctions on all areas that remain in lockdown. For obvious reasons there is currently uncertainty as to the schedule of when the Rugby Club will be allowed to return to play, however having all of the initial line marking done in one visit will no doubt save on cost, as I'm sure you are fully aware.

So if an appointment for the lines to be marked as soon as possible could be communicated to us via this email address as soon as it is agreed, then that would be most appreciated.
