Please find attached the Feasibility Report from Alan Lewis regarding the dogpark project that we met about in summer. We are in the process of covering the cost of this. I think it is a very positive report and we have real potential to develop a multi-use pitch for mini / junior use, mainly for rugby and football use between the ages of 6-11 we also envisage this would be utilised as a training pitch for older age groups and even other sports / community groups who may require the space.
